

PRIVACY POLICY

This Privacy Policy apply to the website and courses offered by Tradimo Limited ("Tradimo" or "us") through https://tradimo.com/ (the "Website"). Use of the Website and services of the Company (the "Services") means that you agree to this Policy, as set forth below (the "Privacy Policy" or the "Policy"). The Privacy Police is an integral part of the Terms and Conditions and Cookies Policy available on the Website.

Tradimo values the privacy of the client (the "Client" or the "User(s)" or "you"). This Policy describes what information we collect, how we use it and if necessary, those with whom we share it.

By using Tradimo, you are accepting the practices described in this Privacy Policy. Your use of the Website is also subject to our Terms and Conditions.

In this Privacy Policy, "Personal Data" or "Personal Information" or "Data" or "Information" may be used interchangeably. We might also use the collective term "processing" to refer to activities such as handling, collecting, protecting, and storing your Personal Data.

For the context of this statement, Personal Data encompasses any Personal Information related to you that either identifies you or has the potential to identify you. This information includes, but is not limited to, your name, address, and identification number.

The purpose of this updated Privacy Policy is to provide clarity on the recent revisions made to both the Privacy Policy and Cookie Policy and how these changes might impact you. To gain a comprehensive understanding of these changes and the terms governing your use of our Services, it is recommended that you read the Privacy Policy and Cookie Policy.

Please be aware that this Privacy Policy is subject to periodic changes. Your continued utilization of the Website following any modifications signifies your acceptance of those changes. Therefore, we recommend checking the Policy regularly for updates. This Privacy Policy has been formulated and is maintained in alignment with relevant federal and international laws and regulations.

1. GENERAL INFORMATION AND TYPES OF INFORMATION GATHERED

The Personal Data of the Users is collected and processed through the Website. The Information we learn from customers helps personalize and continually improve your experience at Tradimo. Here are the types of Information we gather:

Information You Provide: When you engage in activities like searching, reading, viewing content, enrolling in courses, subscribing to our newsletter, using the Website, or reaching out to us through contact information or forms, you offer us information. Through these interactions, you might furnish us with the following details:

- First and last name
- Email address
- Phone number (includes WhatsApp)
- Address
- City, State and ZIP Code.
- IP address

As well as any additional information relating to you that you provide directly to us through our website. Please note that Tradimo will not collect any personally identifiable information about you unless you provide it.

Automatic Information: Similar to many websites, we employ "cookies" to facilitate our operations. When your web browser accesses Tradimo or third-party content hosted by or on behalf of Tradimo on other websites, we gather specific types of anonymous Data that cannot be used to identify you personally. Among the Data collected and analyzed are the Internet Protocol (IP) address, computer and connection details such as browser type, version, and connection speed, purchase history, as well as the content you searched for, viewed, and potentially purchased.

2. HOW LONG WE KEEP YOUR PERSONAL DATA

Personal Data will be retained for the duration necessary to facilitate the functioning of the Website and courses. In cases where the User has granted consent to such processing and that consent remains in force, the owner may hold Personal Data for five (5) years. Additionally, the owner might be compelled to retain Personal Data for an extended duration when fulfilling a legal obligation or under the directive of an authority. Once the designated retention period concludes, Personal Data will be removed. As a result, after the retention period lapses, the entitlements to access, erasure, rectification, and Data portability will no longer be enforceable.

3. HOW WE USE YOUR INFORMATION

In general, we use the Information we collect primarily to provide, maintain, protect and improve our current Website and Services. We use Personal Information collected through our Website as described below and described elsewhere in this Policy to:

- Identify you as a User in our system.
- Provide the content.
- Provide the Services.
- Process the payments.
- Improve our Website and how we operate our business.
- Understand and enhance your experience using our Website and Services.
- Respond to your comments or questions through our support team.
- Send you related Information, including confirmations, invoices, technical notices, updates, security alerts, support and administrative messages.
- Send Information related to upcoming events and news and Information related to courses and Services offered by Tradimo and our selected partners.
- Use for Marketing purposes of Tradimo.
- Protect, investigate and deter against fraudulent, unauthorized or illegal activity.

4. HOW DO YOU GET MY CONSENT?

By using the Website, registering on the Website, purchasing a course, communicating with us through the contact forms or our contact information, accepting the use of cookies by our Website and providing us with Personal Information to communicate with you, you consent to our collection, storage and use of your Information on the terms contained in this Privacy Policy. You may withdraw your consent by sending us your request via the contact information or the contact page.

5. HOW WE SHARE INFORMATION

Information about our Users is an important part of our business, and we are not in the business of selling it to others. We share Users' Information only as described below.

Third-Party Service Providers: We use third-party tools and services that help us to provide our Services in an optimal way and to provide the functionalities of our website. The third-party services and tools may have access to Personal Information needed to perform their functions but may not use that Information for other purposes. Information shared with these third-party services will be treated and stored, in accordance with their respective privacy policies and our Privacy Policy.

Affiliate Programs: We offer our content in conjunction with affiliate programs on other websites. The Personal Information you provide through those websites is your responsibility. Email Address: The email address that you supply to us for the purpose of receiving our email communications will never be rented or sold to a third-party.
